



# Densho Digital Archive Agreement & Application

## **Your Agreement with Densho**

Thank you for your interest in our interactive digital archive of primary sources available via the World Wide Web called the Web-Based Densho Digital Archive (“WEB ARCHIVE”). These terms and conditions of use (“TERMS AND CONDITIONS”) constitute a legal agreement (“AGREEMENT”) between you and Densho (“DENSHO”), a Washington State not-for-profit corporation. Please read this agreement in its entirety. By signing this AGREEMENT you agree to be bound by the TERMS AND CONDITIONS of the AGREEMENT.

## **Ownership and Use of the WEB ARCHIVE**

The WEB ARCHIVE of digital images and interviews is owned and operated by DENSHO.
